At the end of this period, the usual guarantee of the simple replacement of the accused surface of film will, of course, be maintained.

For other films without the GP mention the simple replacement of the accused surface of film will be ensured, without any other compensation. **Extension** is an option offered by Solar Screen on the basis of no experience product/manufacturer offering the possibility of increasing the **film** warranty, at the rate of $1 \in /m^2$ (pre-taxe) per additional year, maximum 2 additional years in vertical installation only.

The mentioned warranty changes for the following cases:

- Tinded and/or metallized glass - Industrial zones - High-salty invironment areas (Near coast < 5 km) - Areas > 800 height neter Apply for the new silver-and natural range with a shortening of 3 years and for all other films with a shortening of 1 year. Important: Temporary appearance

Example:

- Chrome 285XC (Vertical installation in London on clear glass): 10 years product warranty and 7 years installation warranty.
- Chrome 285XC (Vertical installation in Manchester on tinted glass): 7 years product warranty and 4 years installation warranty.
- Cuivre 80XC (Vertical installation in Liverpool on tinted glass): 3 years product warranty and without installation warranty.
- Natural 275XC (Vertical installation in Birmingham within a high-salty environment): 5 years product warranty and 2 years installation warranty.
- Vista 90XC (Vertical Installation in Bristol on tinted glass): 2 years product warranty and without installation warranty.

DO NOT HESITATE TO CONSULT US TO VALIDATE THE WARRANTY OF YOUR PROJECT!

The warranty concept relates to the cracking, yellowing, peeling and the demetallization of the film, as far as all the above conditions were observed and that the guarantee certificate on which figure the production batch number of the film (see in the tube) is well supplemented and turned over to SOLAR SCREEN for each application. Please also send high-resolution images for each installation over 200 m² to us.

Lastly, at the opposite of an interior application film, the external ones suffer more from the solar radiation of atmospheric pollution... also the period of guarantee for external films can in certain cases be compared to the lifespan of internal films.

Be sure to leave 3-5mm of space between the edge of the glass and the film, as well as a drying time of one hour, for the film, before applying the strips, dry, taking care to cover the free edge of the glass (3-5mm) as well as 5mm on the film.

Only the warranty period which is published each beginning of the year on the card of the technical specifications istaken into consideration. The guarantee of the film relates to the peeling, the demetallization, the craking or yellowing.

CONDITIONS

The guarantee is applicable if:

- 1 The film was well installed by an applicator approved by SOLAR SCREEN
- 2 If the applicator carried out well the good choice of the film according to the customer's user requirements and observed the coatings conditions of this one, in particular for external films.
- 3 The end-user well observed the recommendations of maintenance (frequency) for the films, and especially for external films.
- 4 The complaint is founded and well shows the defect of the film.
- 5 The defect is noticed during the garantee period abd from as of the installation date.
- 6 The present has been transmitted to SOLAR SCREEN in the 30 days following the installation date.

Specified: a peripheral luminous edge is necessary to the dilation of the film to the sun. Inevitable small points like pinheads possibly visible with less than three meters are accepted.

- 1 To wait 3 weeks before carrying out the first washing
- 2 Not to use abrasives products, Ammonia defective brushes or scrapers being likely to damage the surface of film
- 3 To use a synthetic sponge or rubber scraper
- 4 To wash regularly the film with clear water added with the non-abrasive product of cleaning of panes of your choice interial films need to clear once a year. External films need to clear three times a year vertical an four times a year horizantal.

The guarantee SOLAR SCREEN is limited to the replacement of the accused surface of the film. SOLAR SCREEN declines any responsibility for the replacement labour and cannot be held for person in charge for the incidence of the film, its effectiveness and the possible thermal shocks being able to result from its installation. In horizontal plan, silicone is obligatory, as well as for the vertical plan, it's recommended to prevent any phenomenon of oxidation.
